**About Measure C:**

Measure C is a facilities bond measure passed on June 5, 2012, by the voters of the West Valley-Mission Community College District. Measure C authorizes the District to issue up to \$350 million in general obligation bonds for the purpose of repairing, rehabilitating, and improving existing facilities, and adding new educational facilities at West Valley College and Mission College.

**About Measure W:**

Measure W is a facilities bond measure passed on November 6, 2018, by the voters of the West Valley-Mission Community College District. Measure W authorizes the District to issue up to \$698 million in general obligation bonds for the purpose of repairing, rehabilitating, and improving existing facilities, and adding new educational facilities at West Valley College and Mission College.

**Duties of the Committee:**

- The Committee shall inform the public concerning the District's expenditure of bond proceeds.
- The Committee may review reports produced by the District to ensure that bond proceeds are expended only for the purposes set forth in Measure C and that no bond proceeds are used for any teacher or administrator salaries or other operating expenses.
- The Committee shall present an annual written report.

**Qualifications:**

- Applicant must be at least 18 years of age.
- Applicant may not be an employee of the District, official of the District, or any vendor, contractor, or consultant of the District.
