

#### Health Care FSA

Pay for eligible **medical**, **vision**, and **dental** expenses that are not covered by another health plan.



#### Limited Health FSA

Pay for eligible **vision** and **dental** expenses that are not covered by another health plan.



### Dependent Care FSA

Set aside pre-tax funds to pay for daycare expenses for children or other eligible dependents

# FLEXIBLE SPENDING A C C O U N T S

AN FSA IS AN ACCOUNT THAT ALLOWS YOU TO SET ASIDE PRE-TAX FUNDS TO PAY FOR ELIGIBLE EXPENSES.

# FSA SAVINGS

TAX SAVINGS ON ELIGIBLE PURCHASES



With an FSA, you save approximately 30%\* on your eligible expenses, making a \$1,000 expense cost you about \$700.

## **GRACE PERIOD**

PLANNING WHEN FUNDS MUST BE USED



Gives an additional period of time to incur claims after the end of the plan year. The grace period applies to the **health** care / dependent care FSA.

**Grace Period Dates:** Claims must be incurred by 03/15/2025.

# **RUNOUT PERIOD**

PLANNING WHEN FUNDS MUST BE USED



Allows extra time to submit claims for eligible expenses incurred during the plan year. The runout period applies to the health care / dependent care FSA.

Runout Period Dates: Claims must be submitted by 03/31/2025

## Why It's Necessary

EBC is required to verify the eligibility of every Benefits Card transaction under IRS regulations with no exceptions.



#### Notification Process

If a Benefits Card transaction cannot be auto-substantiated, you will receive an email alert that you must submit documentation.



## Submitting Documentation

The fastest way to submit documentation is through the EBC Mobile app or by logging in to your online account at www.ebcflex.com.





Always save your receipts

Be prepared to substantiate claims by saving your itemized receipts for all Benefits Card transactions.


